CONSTITUTION

Of The Rebelette Dance/Drill Team Of William B. Travis High School

Article 1

NAME

The name of this organization shall be the "Rebelettes" of William B. Travis High School.

Article 2

PURPOSE

The purpose of this organization shall be to provide a wholesome activity for the students of William B. Travis H.S; by instilling feeling of pride for this organization through service to our school and community, by promoting school spirit, providing quality performances at athletic events and other school activities, striving to represent our school and organization well, encouraging scholarship and good conduct and developing qualities of leadership and self-initiative. We are a team and we will strive to act as one in all aspects. We will work for the good of the group rather than merely for one's self. We agree to abide by the rules and regulations as set forth in this constitution.

Article 3

COLOR

The colors of this organization shall be red, gray, and white.

Article 4 **QUALIFICATIONS**

- A. In order to be eligible for audition, a student must:
 - 1. Have a cumulative GPA of at least 2.0 and be on grade level
 - 2. Have a good attendance record-no chronic tardiness and/or absences.
 - 3. Not have been suspended from school or sent to ALC during the semester of tryouts.
 - 4. Have her application approved by a committee consisting of the principal, assistant principals, counselors and director.
 - 5. Pass a citizenship evaluation from faculty members she had for the current year and/or preceding years.
 - 6. Tryout in front of a panel of judges and be judged on appearance, dance ability and showmanship. The decision of the judges is final.
 - 7. Current members must also audition for the next year. Their scoring will include points for service and dedication to the team to be determined by the director. (Merit Points)

Article 5

MEMBERSHIP

- A. In order to maintain membership in the Rebelettes organization, a student must:
 - 1. Maintain the standards of scholarship, conduct, character and performance required.
 - 2. Follow all rules of the school, district, and Rebelette constitution.
 - 3. Attend all scheduled practices and performances before and or after school, nights and weekends.
 - 4. Be at practice and at school the day of the performance and/or at the final rehearsal in order to perform.
 - 5. Understand that any one absence or three tardies during a week will make the member ineligible to perform the following week.
 - 6. Attend additional practices as called by the director if deemed necessary for the quality of the performance.

- 7. Be able to attend summer practice as called by the director if deemed necessary for the quality of the performance.
- 8. Be on time for practice.
- 9. Contact director, captain, or officer before being absent (failure to do so is considered an unexcused absence and will result in 2 demerits.)
- 10. Remain for entire game or function unless prior arrangements are made with the director.
- 11. Stay at practice or performance until dismissed by the director.
- 12. Understand that absence from practice for tutoring/make up work outside of the designated time must be kept to two per semester.
- 13. Understand that work related absence wouldn't be excused.
- 14. Attend games with team and in uniform regardless of performance status.
- 15. Cooperate with the director and the organization in promoting good citizenship and sportsmanship in school.
- 16. Sit in designated area for only Rebelettes at football games, basketball games and serve as a spirit organization. (Each member must remain in stands unless given permission to leave by director or captain.
- 17. Refrain from participation in any illegal activity such as drinking, smoking or association with drugs.
- 18. Resign gracefully upon failure to live up the requirements.

Article 6

PROBATION

Probation is defined as that period of time during which a member is denied participation in scheduled performances.

- A. Members on probation for any reason will be required to participate fully during class time.
- B. The director will determine length of probation.
- C. Members are subject to probation for the following violations:
 - 1. Disrespect to the director, officers, teachers, or the members.
 - 2. Excessive use of profanity.
 - Cutting class.
 - 4. Lending part of or all of a uniform to a non-member.
 - 5. Use of tobacco products while in uniform or representing the school.
 - 6. Issuance of a "minor in possession" summons.
 - 7. Receiving an "F" in a course for a six weeks grade.
 - 8. Unacceptable behavior as determined by the director, including leaving campus without permission.
 - 9. Three unexcused absences constitute a probationary period as determined by the director. Three tardies=1 unexcused absence=3 demerits.
 - 10. 10 cumulative demerits per semester will place the student on probation.
 - Note: Director and/or officers may assign demerits
 - 11. Grade sheets will be checked every week, if failing any class you will not be able to perform.

Article 7

Disqualification of Membership and Reinstatement

- A. A member shall be disqualified and dismissed by the director as a result of any of the following:
 - 1. Receiving an "F" for two consecutive grading periods, or 2 F's in the same semester. 2. Student will be rescheduled to a different class.
 - 3. Unexcused absence from a required performance.
 - 4. Any assignments made to the Unsupervised Home Based Suspension or ALC.
 - 5. Any serious violation of school policy or student code of conduct.
 - 6. Using or being under the influence of drugs and/or alcohol.
 - 8. Participation in illegal activity and /or gang related activity.
 - 9. Persistent lack of discipline or poor attitude.
 - 10. Accumulating 25 demerits.

- B. Membership as a Rebelette is a privilege. Should a member be suspended anytime throughout the year for any reason, she must re-tryout in order to reinstate her membership.
 - 1. Suspended members are not to wear any Rebelette clothing until they are reinstated.
 - 2. A member who "fails off" the team may try-out for reinstatement to the team the following year on the condition that she is on grade level and meets all tryout qualifications.
 - 3. A member who goes to another organization (Ex. Cheerleading) or leaves due to health concerns or pregnancy may try out the next year. Applicants must meet all grade, attendance, discipline and citizenship requirements.
 - 4. If a member quits the team, she will not be allowed back on the team during the year she quit.

ARTICLE 8

GRADING

- A. The grades in the Rebelette class will be based on daily work in class, performance, skills tests, and written tests.
- B. In order to maintain a good grade, these requirements must continue until the end of the year.
- C. Dance credit for this class and all the practice requirements for this class must fulfill specific requirements for performance, which will be evaluated by the Director as in any academic class.

ARTICLE 9

FUND RAISING AND EXPENSES

- A. All members will be required to raise a certain amount of profit during the year for the team's expenses (the "fair share" will be determined during each fundraiser)
- B. Fundraisers will be held in order for the members to raise their profit.
- C. Items purchased through fund raising remain the property of the Rebelettes.
- D. Money raised for Rebelettes stays in the Rebelette account regardless of the students' status (Ex. Suspended from the team or quits)

ARTICLE 10

UNIFORMS

Section I – RULES FOR PERFORMING DRESS UNIFORM

- A. The Dress Uniform of the Rebelettes shall be provided by the school and will be respected at all times.
- B. The Rebelette Uniform is to be spotless at all times and ready for inspection before every performance.
- C. The Rebelette Uniform is never to be worn incompletely or separately, unless indicated by the Director. Ex. Do Not "strip" down after the performance.
- D. Jewelry is not allowed with the Dress Uniform.
- E. All make-up should be in good taste and suitable for the performance area.
- F. Specified lipstick, eye make-up, blush and hairstyle are required and are considered part of the uniform.
- G. Rebelette members must change out of their Game Uniform and into clothes in a private home within one hour after any game or activity in which the Game Uniform is worn.
- H. Rebelette members are expected to take pride in their Game Uniform and to do everything possible to keep it in good condition. It must be protected in a hang-up bag at all times, whether being stored or carried. **Do not spray perfume, hair spray, etc. on or near uniform.**
- I. All appearances in the Rebelette Game Uniform must be approved by the Director. The uniform is not to be worn in public, except when the member is traveling to and from school or a performance.
- J. Rebelette member are expected to wear the Game Uniform with pride and confidence, maintain poise, good posture and smile.
- K. <u>HAT BOX DISTANCE</u> between you and any male should be honored when in uniform at all times.

L. While in uniform, after being called to attention, you are not to speak to anyone other than your Officers, Director or school officials unless given permission to do so.

SECTION II- ALTERATION AND CLEANING OF GAME UNIFORM

- A. As long as the Game Uniform is checked out to a member, she is responsible for its cleaning and upkeep.
- B. Each member is required to pay for any necessary alterations made to her uniform. Alterations can be made only by an approved seamstress. The uniform is NEVER to be cut.
- C. Damage to any part of the school-issued uniform will be paid for the wearer. Any display of misuse of the uniform will result in possible suspension from Rebelettes.

SECTION III-RULES FOR PRACTICE AND FRIDAY UNIFORM

- A. The practice and Friday uniforms will be provided by each member.
- B. The Friday uniform will be worn by members on game days and other designated occasions.
- C. The practice uniform (leotard and tights) will be worn by members every day for dance practice. The leotard and tights must be properly marked with the owner's name.
- D. The uniforms are to be worn only as a group, never individually.

Article 11

FOOTBALL SEASON

- A. An inspection will be done before each game.
- B. Rebelettes shall stay in her assigned seat the entire game. No one is to change seats or look backwards into the stands unless directed to do so by an officer or the Director. No one will leave the stands without permission from the Director and only then in the presence of an officer. Trips to the restroom will be kept to a minimum and only for emergencies.
- C. <u>Drinks, food and candy are not allowed without permission.</u> Closable <u>water</u> bottles that can be concealed in a bag may be brought. No one is allowed to receive anything from outsiders without permission from the Director.
- D. Rebelettes will follow the cheers started by the Varsity Cheerleaders. At the sign from the Captain, all members will rise for such reasons as the kick-off, singing the National Anthem, and School Songs. A Rebelette will not jump up individually during the game or start organized yells without permission of the officer in charge. No Rebelette is ever to boo or act in an un sportsmanlike manner toward the opposing team.
- E.The Captain will give the signal to file on to the field to line up for halftime. There must be NO TALKING from this point until the members return to the stands. ABSOLUTELY NO RUNNING IN UNIFORM.

 <u>Talking to outsiders</u> or any person other than a school official is not allowed until <u>after the game.</u> No unauthorized person may sit in the dance team section.
- F. Rebelettes shall remember that she is attending a football game for two major reasons.
 - 1. To lend her support to the football program by backing the cheerleaders and watching the game.
 - 2. To perform with the band and entertain during half time.
- G. ALL PRACTICE CLOTHING BILLS NEED TO BE CLEARED BY THE 1ST DAY OF SCHOOL TO PERFORM AT HALFTIME.

ARTICLE 12

BASKETBALL SEASON / BASEBALL SEASON

- A. Rebelettes is also a spirit organization. Each member will be required to attend specific basketball and baseball games.
 - 1. Rebelettes should be at the game site 15 minutes prior to the start of the game.
 - 2. On school nights, Rebelettes may leave at 9:30pm from games.
 - 3. There shall be no food, candy, or drinks in the gymnasium.
 - 4. No jewelry shall be worn.
 - 5. No cell phones.

ARTICLE 13

BUS TRIPS

- A. On every bus trip, you are to go and return with the group unless a <u>Car Riding</u> note from the parent is submitted and approved <u>prior to departure</u>. Requests not in writing or not presented beforehand will be denied. Rebelettes are <u>not</u> allowed to ride home with friends or boyfriends. It must be a parent / adult / guardian with written permission.
- B. Rebelettes must follow all bus rules.
- C. When an officer or director asks for attention, all talking ceases.
- D. Do not change clothes or spray hair spray, perfume, etc. while on the bus.
- E. Upon arrival, members must remain seated until told to leave by the director.
- F. Members must make sure that all equipment and belongings are removed from the bus along returning home. Each girl is responsible for equipment checked out to her.
- G. Members must show respect for the director, officers, bus drivers and other passengers at all times. Violations will be handled by the director.
- H. All cell phones must remain off on all rides to an event. They may be turned on, on the way home after the director gives the o.k.

ARTICLE 14

PERFORMANCES/ AUDITIONS

There will be auditions for each performance. (game, pep rally, contest, etc) If a Rebelette is <u>absent for tryouts</u>, she will not be able to be in that performance. Our goal is for everyone to perform, but if a girl cannot execute the routine as well as the majority of the team, she will be cut from that performance. Auditions are held to maintain and improve the quality of Rebelette performances. Every effort will be made to help each individual to meet the standards in memory, technique, projection and showmanship. In improving the quality of our performances, we will instill pride and confidence in each individual for being a member of the Rebelettes. If a girl is cut from a routine **for any reason** she must still attend the game in proper uniform and perform all other Rebelette duties with the team.

ARTICLE 15

CONTEST SEASON

- A. Contest season begins ONE week after the last football game.
- B. Rebelettes will attend 2-3 contests per year.
- C. All Rebelettes will have the opportunity to participate in at least one (1) routine.
- D. Each girl will have to raise an allotted amount of money for contest. This is above their "fair share" that must be raised to help run the organization. If they do not fund raise the money, then they will pay the difference. All practice clothing bills need to be cleared by January 1st to perform in contest.
- E. Rebelettes may enter solos, duets, trios, and ensembles. Each girl must pay for her own fee.

ARTICLE 16

SPRING SHOW

- A. Spring show will be the final performance for Rebelettes.
- B. The Spring show date will be set by the Director in the Fall.
- C. Officers will make up dances and help with class dances.
- D. Tickets will be sold by the team and parents.
- E. Officers will be responsible for costuming of the dances.
- F. The theme will be decided on by the director and the Spirit Leaders.
- G. Seniors will be presented on the last night of the Spring show.
- H. Girls owing money will not be allowed to participate in the Spring show.

ARTICLE 17 BANQUETS / PARTIES

Rebelettes will have a Winter party and end of the year banquet. Cost of the banquet will be determined by the amount left in the Rebelette account at the end of the year.

AWARDS

The following awards will be given to Rebelettes at the end of the year banquet. Awards may only be received if the student is in good standing with the team. (all debts paid and still an active member of the team)

ARTICLE 18 **DEMERITS**

Demerits will be calculated during the following times.

- 1. Immediately following try-outs until the end of school (for new members)
- 2. Summer practice until the end of the school year.
 - -Demerits will start over for each calculating period.
 - -Three demerits RECEIVED in a week will result in <u>not performing</u> at the next team performance.
 - -Each demerit will result in an assignment of 25 jump squats to be done immediately.

ARTICLE 19 MERIT POINT SYSTEM

A. Requirement –

To remain a member in good standing, each girl must accumulate 550 merit points per year. Girls who do not earn the required merit points will not receive their Award letter at the end of the year nor be allowed to perform in Spring Show and will not be allowed to remain on the team for the next year.

Section A – Merit requests will be used for the merit system. Any Rebelette failing to turn in merits on the required day will not get credit for those merits. In the event of an absence they must be turned in on the day they return. Section B-5 merits will work off one demerit. Merits must be already documented in order to clear a demerit. Section C - Members may receive merits for service to the organization as well as self-accomplishments and improvements approved by the director.

ARTICLE 20 APPEARANCE

All members are expected to maintain a neat, clean appearance and fit body. Tattoos and / or body piercing must be concealed at all times. Unnatural hair color is not appropriate.

ARTICLE 21 MANAGERS

The director shall choose Rebelette Managers each year. These girls are entitled to all the credit and privileges of membership, although they are non-performing members. As such, they are subject to the same rules and regulations binding all other members.

- A. Managers are responsible for the following:
 - 1. Number and paint equipment / costuming
 - 2. Check out equipment and costuming and be responsible for its return
 - 3. Keep storerooms clean and organized
 - 4. Go to games and performances and aid in anyway necessary while at stadium or on the buses
 - 5. Sit on the edges of the formation before game to ensure that no one sits in the section reserved for the dance team
 - 6. Collect props at games when necessary
 - 7. Carry the first aid kit, banner, etc. to all games
 - 8. Go to competitions to aid in any way necessary
 - 9. Aid the officers and Director in any way
 - 10. Aid in paperwork and errands

ARTICLE 22

OFFICERS

- A. Rebelette Officer tryouts are held in the Spring
- B. Each candidate must meet the following requirements:
 - 1. Prepare a project and tryout in front of qualified judges
 - 2. Meet all eligibility requirements of team members
 - 3. Have been on the team the full year before auditions
 - 4. Attend an officer camp in addition to line camp
 - 5. Sign and abide by a special officer contract
 - 6. The judge's decision is final and will not be changed
- C. Duties of the officers:
 - 1. Check rank roll, uniforms, make up and props at all functions
 - 2. Date and collect rank excuses and forms to turn in to director
 - 3. Supervise her rank in all areas and give demerits accordingly
 - 4. Inform rank of upcoming events, duties, and deadlines
 - 5. Check for items left behind at end of practice
 - 6. Pick up any trash left behind at end of practice
 - 7. Return tapes and tape player to office at end of practice
 - 8. Keep accurate records of merits and demerits
 - 9. Aid director and assume duties as determined when necessary by director
 - 10. Lead stretches and insure that all rank members are stretching and not talking
 - 11. Assist in choreography and teaching routines
- D. Officers may be demoted to the line for the following:
 - 1. Being placed on grade or conduct probation
 - 2. Failure to maintain the standards of the office
 - 3. Persistent failure to carry out assigned duties
 - 4. Disobeying the director or going against her wishes

ARTICLE 23

SPIRIT LEADER

Section A – This organization may have any of the following: President, Vice President, Spirit Coordinator, Chaplain, Secretary, Historian, and Class Representatives

Section B – Qualifications for Spirit Leader

- 1. Each candidate must audition in front of their peers and complete the project
- 2. Must not be on probation at time of selection
- 3. Must be a participating member of the Dance Team
- 4. Must not hold a job that would interfere with the duties of the office
- 5. Must have proved self worth in leadership, character, and sportsmanship
- 6. Must sign and abide by the social committee contract
- 7. Must not have been on suspension for demerits or contract during the year in which she auditions
- 8. A social committee member who violates her contract will lose her office and return to the team as a line member
- 9. A social committee member who is put on probation of grade suspension (receives an "F") will lose her office and return to the team as a line member
- 10. In the event a social committee member loses her office the Director may or may not fill her position with another, already active, spirit leader member. The decision will be based upon needs of the team

Section C – Duties of the Spirit Leader

- 1. President
 - A. Schedules all social committee meetings with the approval of the Director
 - B. Makes arrangements for the spring banquet with the approval of the Director and in conjunction with the Booster Club officers
 - C. Shall preside over all social activities and the planning thereof and shall oversee the duties of the other committee members and insure the completion of those duties. The president will schedule, handle and delegate duties for all social activities
 - D. In charge of service projects and public activities
 - E. Participation in the summer leadership workshop
 - F. Will attend extra days of summer camp to prepare for the upcoming year
 - G. Will report to the Director weekly to decide on activities to be done for that week
- 2. Vice-President
 - A. Shall assist the President in planning the team's social activities\
 - B. Assist the President in all banquet arrangements
 - C. In charge of the social activity arrangements: summer camp, fun activities, Christmas party, etc.
 - D. Is responsible for matching big/little sisters and keeping them current
 - E. In charge of social committee ensemble for contest
 - F. Participation in summer leadership workshop
 - G. Will attend extra day s of summer camp
- 3. Spirit Coordinator
 - A. Provide motivational support (IE. Notes and posters)
 - B. Prepare a bimonthly motivational activity for the team
 - C. Provides emotional support before performance
 - D. Participation in summer leadership workshop
 - E. In charge of incentive charts (honor roll, zero demerits, and spirit girl of the week)
 - F. In charge of quotes of the day, bead incentive, contest countdown, etc.
 - G. Attend extra summer days
 - H. Attend leadership workshop

- 4. Chaplain
 - A. Will serve as the leader of EnCroix, Fellowship of Christian Dancers
 - B. Shall oversee the spiritual aspects of the team
 - C. In charge of the EnCroix bulletin board
 - D. In charge of the EnCroix ensemble for contest
 - E. The liaison with FCA and public relations for the club
 - F. Attend extra days at summer practice
 - G. Attend leadership workshop
- 5. Secretary
 - A. Responsible for the correspondence (IE. Letters, thank you notes, get well cards, birthdays, Rebelette of the week poster, etc.)
 - B. Shall take notes at all meetings and turn them into the Director's social committee member notebook
 - C. Prepares posters and handles advertising of Rebelette events
 - D. Shall be responsible for the monthly bulletin board in the dance room
 - E. Attend extra days at summer practice
 - F. Attend leadership workshop
- 6. Historian
 - A. Shall be responsible for taking pictures and/or video footage of the team at all gatherings for the Rebelette video and scrapbook to be presented at banquet
 - B. Collects memorabilia for scrapbook; clip articles concerning the Rebelettes
 - C. Prepares the scrapbook presented at the spring banquet
 - D. In Charge of the memory video of the entire year
 - E. Will ensure Rebelette yearbook coverage
 - F. Attend extra days at summer practice
 - G. Attend leadership workshop
- 7. Senior, Junior, Sophomore, Freshmen Class Representative
 - A. Shall be responsible for spirit gifts for the Rebelettes and other organizations
 - B. Shall work closely with the president and the vice –president in organizing the various sprit gifts, the teacher appreciation day, contest buddies, etc.
 - C. Shall be the class liaison to the director and dance officers by providing a suggestion box and presenting any suggestions at the social committee meeting
 - D. Attend extra summer camp days
 - E. Attend leadership workshop

Section D – Selection of Social Committee (auditions to be held in the Spring)

- 1. Prepare a project and tryout in front of your peers
- 2. Must be in good standing and not on probation at the time of elections
- 3. Must sign and abide by the special social committee contract

REBELETTE CONDUCT CODE

The Rebelettes is a dance team composed of fine young ladies. Rebelettes is an honorable and respected organization. We are proud to represent Travis H.S. in all activities. Every individual should set a good example as a student in all classes by being responsive and respectful to teachers, administrators, and other students. Good attendance and exemplary lady-like behavior are a must. Responsibility and dedication are very important to our team. Rebelettes are responsible for their actions and their belongings. Rebelettes are dedicated to making our team the best that it can be.

The rules set forth in this constitution shall govern the conduct of each member of this organization. It must be understood that each girl is responsible for upholding and seeing that others uphold the Conduct Code at all times. It is not the purpose to create ill feelings in the event of turning members into the Director, but to encourage the maintenance of the high standards and ideals set forth by the constitution of this organization. Membership in the Rebelettes is a privilege and any student not upholding the standards of this organization or completing her duties will be dismissed from the team. Students who fail to comply with the rules set forth in this Constitution will be dismissed from the team. Any offenses not covered by this constitution, but which are clearly and logically offenses, shall be declared by the Director. Any disciplinary action needed will be in full accordance with school and district policies that are approved by the principal and administration of Travis High School.
